REGISTRATION:

sign up in the student center. we only have 35 spots available at this point: 7 leaders 28 students. it is possible to get more spots only if we fill these up first. your deposit of \$25 secures your spot. the final day to pay the deposit is

sunday, february 20th. the final payment of \$75 is due by february, 27th. please fill out our harris creek release form and turn it in with your deposit. students must have the release form and the final payment in order to leave harris creek.

DRESS CODE:

there are always a lot of questions about appropriate attire on youth events. it has become pretty clear that some youth ministries have different standards than others, and then some of them have a hard time laying down the 'dress code law'. students and parents, the reason for these parameters

is so we will not have to disrupt the focus of the retreat. it is up to you to keep the retreat focused and this is important. we will not be swimming so the swimsuit question will not be an issue. in general, the dress code is: be smart, be prudent, be modest, and be respectful.

teaching students what it means to be loved and what it means to love others.

DAMAGES:

be aware that you are personally responsible for all damages to any facilities including the dorms, auditorium, and cafeteria. if damages occur, disciplinary action will be taken and you will be billed immediately.

TRANSPORTATION/ FOOD:

camp buckner is 2 hours away so we will be taking cars. leaders will be driving. no students will be allowed to drive. we will not be stopping for dinner on friday evening or lunch on sunday afternoon. students are welcome to bring a sack lunch/dinner with them for

the drive on friday. we will have plenty of snacks for the drive home.

ACCOMMODATIONS:

each night we will be staying in cabins. we will be split into two cabins. one for guys and one for girls. each 1/2 of the dorm will have their own showers and bathrooms.

Permission, Consent & Liability Release

Permission for Participation & Consent to Medical Treatment

I, the undersigned Parent or Guardian for _____ (“Youth”), give permission for Youth to participate in the Activity, and for any adult representative of HARRIS CREEK BAPTIST CHURCH, whether an employee, staff member or volunteer (“Representative(s)”), to obtain and receive from any health care provider health information and documents pertaining to the necessary treatment of Youth, and I further consent for Representative during the duration of the Activity to consent on behalf of Youth to any medical, surgical, or other health care treatment determined by consultation between Representative and health care professionals to be necessary treatment for Youth during the Activity. I assume financial responsibility for any medical bills incurred in this regard. Should Youth have to return home before the remainder of the group for medical or disciplinary reasons, I hereby assume responsibility for any additional costs thereby incurred.

Affirmation, Express Assumption of Risk and Liability Release

I further hereby affirm that I have been well advised and thoroughly informed of the inherent hazards associated with Youth’s participation on this trip. I further understand that there are certain risks, both foreseeable and unforeseeable and inherent as well as avoidable, that are associated with the travel and other events involved in this Activity, including but not limited to such risks as vehicular accidents and any other accidents (e.g., getting lost, falling while hiking, climbing or exploring in the outdoors, injury during participation in athletic contests or games, etc). I nonetheless agree for Youth to proceed with this Activity and to assume all risks in connection with this Activity for any harm, injury, or damage that may befall Youth as a result of his/her participation in the Activity. I understand and agree, in consideration of Youth being permitted to participate in this Activity, that neither HARRIS CREEK BAPTIST CHURCH nor its Representatives may be held liable in any way for any occurrence with this Activity that may result in injury, sickness, death, or other personal or property damages to Youth and further agree to defend and hold harmless and indemnify HARRIS CREEK BAPTIST CHURCH and its Representatives from any claim by Youth, Youth’s family, estate, heirs or assigns, arising out of Youth’s participation in this Activity as well as for any claim asserted by anyone else arising out of any act or omission by Youth while involved in this Activity.
